By attending the Advanced Football Centre by Adriano's Soccer Schools, you explicitly agree to the following terms, conditions and accompanying policies.

PAYMENTS

A standing order must be set up to debit your account on the 28th of every month to the bank details provided by Adriano's Soccer Schools. The price per month is £40.

Please note, if we do not receive payment by the first week day of the month your child's place at the AFC could be terminated.

Accepting a place at the Advanced Training Centre is on a 12 month contract.

CANCELLATION & REFUNDS

You have 14 days cooling off period from signing the contract to cancel.

We will not offer any refunds if your child is unable to make a session.

Our sessions take place at Halo Leisure, Bridge Street, Leominster HR6 8EA. If the centre is closed due to a bank holidays or Christmas, the monthly fee will be unaffected.

In addition to the cost of facilities, the monthly fee contributes towards insurance, coaches fees, administration costs and the labour involved in arranging matches and networking for promising students.

AGE RESTRICTIONS

The current age range is 8 years of age to 12 years of age.

TOILET ASSISTANCE

We can walk younger children to the toilets and wait outside for them, but we can not assist nor supervise them using the toilet.

LOST PROPERTY

We ask that children do not bring any items of high or sentimental value with them to the sessions. We can not be held responsible for any items that get broken by accident by other children or go missing. We do not own the venues that we use and therefore can not guarantee the return of lost property. We will hand any items we find at the end to the Lost Property of that particular venue.

If we are able to identify the owner ourselves we will contact them to inform them and negotiate collection.

COLLECTING & DROPPING OFF YOUR CHILD/REN

We ask that children are not dropped off any sooner that 10 minutes before the session starts. Please ensure that you drop off your child to the attention of one of the coaches. Adriano's Soccer Schools reserves the right to charge a fee for late collection of any children. This may be charged if a parent or guardian arrives more than 10 minutes past the finishing time. It is then a further £5 for every half hour that passes, up until collection. This will be due at point of collection.

Failure to pay could cause the child not being allowed to attend the next session, or other events ran by Adriano's Soccer Schools, until the debt is settled.
